I'm not even fully supportive of the entirety of the campus protests' cause, but I do strongly believe that people (and especially young students) should have the right to non-violent protests, especially within the safety of a university environment. The images of police in riot gear rolling into squash an encampment that had only been up for a few hours is pretty disheartening and disappointing, to say the least.

I fully understand that since I'm not a large donor or overtly active within the Alumni community my words might not mean much, but fo the first time since graduating from the university, I feel like there is a bit of a black cloud hanging over it in my mind and I'm disappointed to be associated with it.

I also find it ironic that as students in the 2000s we had to endure walking from the C-Train station with graphic images from antiabortion activists daily for months, but a small gathering of students setting up an encampment is squashed with riot police within a few hours.

Hi ,

Per our conversation, attached is the sheet we provided those who set up encampments which outlines the policies in question. Temporary structures in protests have not been allowed for some time. To answer your question about dates, and to provide the full policies:

- Use of University Facilities for Non-Academic Purposes Policy has an effective date of March 2010 and was last substantively updated in 2015.
- Special Events Program has an effective date of February 2007 and was last substantively updated in 2020.
- ELT directive was established clarifying that the permission required for temporary structures in the Special Events Program would not be given on April 29. This was not seen as a change in policy, but an attempt to clarify existing policies.

Our Statement on Free Expression is also relevant. Created in 2019, it articulates the right to free expression and its limits, and clearly articulates that we may "reasonably regulate the time, place, and manner of expression to ensure that it does not disrupt the ordinary activities of the institution."


